AGM

Changes to the club's constitution.

Over the past year the committee have been working on a revised constitution to update the

current version which was issued in 2012. There were a number of anomalies in the current document not least of which was the fact it referred to itself as the Club Rules.

As presentation was made on the proposed changes and input was given by a number of members including Jean Roscoe, Andy McLeod and Peter Smith all of whom couldn't attend the meeting.

Following the presentation and a lively discussion with particular attention being given the dissolution paragraph the proposed document was put to a vote. The updates were carried by a majority of 12 with 2 abstentions.

It was agreed that a review of the constitution would be added to the AGM agenda in future years.
